All sites are 20x20. Water access is available to all vendors, but hoses are not provided. Rental fees are based on the amps required to operate individual booths. No more than one unit is permitted on each site. Storage units and personal campers of any kind are prohibited within the Fair grounds. Camping facilities are available close by, and we can furnish you with that information on request. Any damage incurred to the breaker box or to the knockouts will be the responsibility of the vendor to replace, parts and labor

Set up day is scheduled for Sunday the 19<sup>th</sup> after 4pm and any time on Monday

The McCracken County Fair is not responsible for any booth left unattended during the Fair and make no guarantees with regards to attendance, weather conditions, or amount of sales by vendors. Each vendor must include proof of liability insurance when returning this contract to cover all items on the rental site.

Booth rental is made on a first come first serve basis. The mailing of this contract does not constitute a contract until it has been returned to you, with a receipt for your monies. If there are no sites available when we receive your contract, we will return your check/money to you. There will be no refunds made on rentals after June 15<sup>th</sup>, 2022. All requests to cancel must be made in writing and postmarked at least one week prior to the deadline.

No vendor is being offered exclusive rights on any item. You may sell what you have contracted for, but must also be aware another vendor may also be offering a similar item. There are certain items that McCracken County Fair can not sell, due to our contractual obligation with Belle City Amusements.

All vendors must comply with State and Health Department regulations that govern food handling. The County Health Dept will be by to inspect your operation. *The fact that he charges you is why we dropped our fees.*

Fair vendors CAN NOT SELL the following items: Cotton candy, candy apples, caramel apples, corn dogs, funnel cakes, your expected midway foods.

McCracken County Fair will not permit the sale or use of any alcoholic beverages within its gates.

Pepsi has the exclusive rights on all beverage sales, including water. The sale of all other beverages is prohibited on Fair grounds. All drink products sold during the Fair **MUST** be purchased from The McCracken County Fair. Any advertising signs for other beverage companies must be removed. Vendors failing to follow the rules and conditions will be subject to immediate removal from the grounds with **NO** refunds of any fees.
